Dear Mr. Hallinan, Public Inquiry Unit,

I received your letter in regards to recent faxing to your agency in matters that only touch the surface of my actual needs to contact legal enforcement agencies.

The matter is a life and death concern and outcomes for persons who are in the mix of an intractable conflict debate that there seems to be no one willing to commit to a discussion and forum to resolve the matter and aftermath of these concerns.

These include disturbing reporting that is found online against a whole chunk of the Ryan White Care Act funded social services agencies. In that these reports are found on Glassdoor, it is my opinion that this can be taken to a court level evidential testimony if you consider the outcome of

First Amendment protections for anonymous speech online were dealt a serious blow earlier today when the United States Court of Appeals for the Ninth Circuit issued its opinion in *United States v. Glassdoor*. In its opinion, the Court ruled in favor of the US government's efforts to compel Glassdoor to unmask anonymous reviews of employers by employees posted on the site.

In this case it is not the employer that is asking for this open review, but from the client's perspective of how the reviews across the board region to region, from the level of employee tier relationship aspect actually subsequently impacts to a high degree to be gravely concerning places the client services standard and quality of care at risk of community-wide failure for persons living with HIV/AIDS in the United States of America.

This matter is a federal level complaint, but the federal agencies involved will not provide an "official capacity" agency to respond a response of responsibility for these reports that are showing glaring and extremely disturbing to read and collect the trending message that is generated by their lack of concern or compassion to resolve these matters that are in fact killing people instead of supporting people with HIV/AIDS in this country.

I myself have been a targeted victim of this problem that no one seems to want to acknowledge or address.

I was involved in an 11-month hate and harassment campaign that targeted me and my HIV residential tenancy that

resulted in a filing for unjust eviction against me on November 30th, 2016, the day before World Aids Day. This was in Denver Colorado.

I was in fact involved in community improvement and issues awareness project of developing a startup adult consent thought and practices school.

I in fact have on record on my network 6 students that I had finally vetted into being able to conduct resourceful educational sharing involved in my community project space.

But social services collapsed such effort [ illegally ] by conducting a hate and harassment campaign targeted against me, that the community leadership itself was denying the capability for me to communicate to the community any resource to identify the hate source and terminate it.

Any attempt I had attempted was met with a huge bias no contact, no services, denial of communications, denial of the truth, termination of services, and we ended up the leadership of hate win by their "so-called" authority to conduct such "HIV surveillance program" and "intervention" constructs that are extremely illegal.

It would not become apparent by client inability to communicate these facts. This attributed non-ability to report is established in the Ryan White Care act policy complaint process as non-effective bullshit.

What has happened, we have had to rely on "employee tier" reporting because client reporting is completely ignored. This is totally unamerican.

At the time of my eviction process court proceedings, I had not yet been able to identify the hate source myself. So, I choose to voluntarily move out with a date of December 31st, 2016. It would not become apparent until after my attempt after attempt after attempt to get a case manager meeting with Colorado Health Network that I finally had to get my mother involved to act as an agent to get them to call me back and schedule a new case manager meeting.

I have the records of all of the attempts.

Most of this is conducted via Email. This cycling through many case managers.

My mother was given the excuse that I was not contacting the correct case manager even though Angela Keady the first contact I have with Colorado Health Network from the beginning had been actually invited and was a listening participant into my school Google Hangout Space that I was communicating to the community about my efforts, missions, and messages, and the persons involved that seem to have connected to my presence in the community.

But social services did not like this. They are a bunch of racist gossiping queens that violate the privacy of clients they are supposed to be protecting. All you need to do is read the employee reviews of Colorado Health Network aka Denver Colorado Aids Project.

But you will remain ignorant to this --, right? Even though I explained just now that this is evidence that is actually court level acceptable if the matter was to be taken into standing.

Reports against Colorado Health Network reflect, "Dishonest Business Practices, To Stay Away. They Violate The Privacy of Clients, one report noted that "If you don't gossip like a teenager, you will be an outsider" and another report says they had a big investigation of racism and discrimination. Two employees quit. The investigation was reported as inconclusive.

The author of that last mention has this to say in conclusion:

Q: "How can an organization thrive when a top official is racist? If you are a woman or person of color, it is very hard to move up in the org and be heard. If you are a cute, white male, you

will do well in this company"

A: The reason is that there is a hate conspiracy here affecting motives of unprofessional actions, interferences, and retaliation against dissenters, and protection for wrongdoing that soars all of the way up the chain to the CDC HIV Director as my attempts to uproot this at every single level - attempted --- to get a response to conduct an accepted complaint to be processed and acted on.

So far that has not yet occurred.

A completely back assward installment of supportive function as a Ryan White Care Funded social service non-profit federally funded agency.

There is a HUGE SCRATCH ON THE CHALKBOARD WITH FINGERNAILS HERE --- and still, no one seems to be able to take the time and incorporate the "legal standard" of evidential tracking that proves this conspiracy and terminate it ASAP ---

This as a continued conflict-avoidance as ignorance of fault so misguided there can be no END to the HIV epidemic if a segment class of persons is left out of the interdependence of needs and vital resource connectivity to provide care that has been intentionally abused and misplaced that treats this certain class of persons to die instead of thriving. They die needlessly from chaos life dynamics caused by social services refusal to provide services to this classification segment of our HIV communities.

This trend is showing to be a nationally systemic problem region to region on Glassdoor.

The message the system is currently SHOUTING without intervention is  
GO FUCK OFF AND DIE!

I am one victimized by the system --- one of many.

I am slighted here to have no HIV DOCTOR provider at the present time that I can have an honest physician/patient relationship internal of my actual HIV provided medical care.

This condition is unacceptable and requires an outside agency to enforce the law to provide services and conduct reasonable discussions surrounding the quality of care that I individually am involved with locally here in my hometown of San Bernardino.

Instead of that conversation moving forward, conflict-avoidant is the standing presence of the involved in this conspiracy. If they were not so predictable, it would be natural for them to be curious about the life and death struggles of this segment population --- and they are not.

Do you fall into the category of compassion and concern or do you too fall into the category of defending a hate conspiracy that injures the HIV community to a point there can be no end to the HIV crisis --- and on the very end of this --- no trust in the system --- and in that distrust of a system --- the erosion of trust leads to murder and mass shootings.

The classification and the hidden agenda of social services and doctor provider care are based on a faith orientation belief that religious rights based on the association of this particular classification of persons as being of the sinners. Not worthy of services and provider care.

Don't --- I mean it - don't think this is not accurate to the disclosure of this initial complaint I have here.

If what I just mentioned was made up hype, then there would not be a case in court level arguments named:

County of Santa Clara Vs Health and Human Resources [ HHS ]

That would not exist.

But it does and further affirms my association to why this conspiracy, a hidden agenda, to disenfranchise an entire population to write them off as sinners and deserve to go die - the message once again here is

FUCK OFF AND DIE!

Enclosed in my written hard copy words packet is an excerpt of Pope Francis when he appeared to address the Nation of the United States before Congress.

Following the understanding of these words, it is non-Christian and a matter that Lambda legal argues that following the beliefs of this faith-based denial of care choice of religious freedom on behalf of the healthcare system the Trump Administration has crafted is highly destructive to the ability to end of the HIV crisis totally and to the matter actually those involved in this denial of care are slated to die.

This is a matter of urgency that cannot wait one more day to proceed to obtain an "official capacity" agency to respond a response of responsibility for what has occurred that can be legally argued and proven in court. A hate conspiracy.

Shall I file such a case, even if it requires me to file it [ with a learning curve of legal standards ] myself without the assistance of an attorney?

For if I cannot find one agency by the end of August, my birthday is September 1st, I will not let one more day pass by without my efforts of public awareness and communications upon the system that can involve itself to a course correction of this wicked problem of intractable conflict to have an open and honest discussion and in that discussion do something right for a change.

The better solution for the entire society is to meet together in a peace accord type of affair and discuss the realities of the real world on the ground outside and in the trenches of the policy that is highly unethical if they cannot admit their fault and have such a discussion in the first place. It is gravely and severely effecting the community and society as a whole by creating a major cause of the erosion of trust that the Washington Post article states:
