I did not desire to come back from my need for a reprieve from the haters everywhere. I left my computer there. I wasn't sure if my mom was going to get it but I didn't talk to my mom. I wanted to go onto the train. That's what I want, I want out.. So I'm heading on the bus to Ontario for a new phone. I couldn't get my train ticket purchased. For some reason, I could not download any app. I was able to browse the internet for some reason the amtrak.com website would not approve my transaction. For some reason. I tried to call the Voice Customer Support number for Amtrak. The estimated time was like 2 hours. I tried Every Which Way but Loose eventually my time and battery went out. Already at the tracks ready to go. My trip's itinerary is to head on Amtrak to New York. I wanted and still do need to find some sort of consulate and/or court remedy for something that I've actually been dealing with, criminal actions against me that I have been really really really experiencing and documenting since 2005. I was heading to the United Nations to Renounce my citizenry in this seriously sad state of priorities in this country. Somewhere on planet Earth somewhere a country that has its priorities right.
